2. The paper has contractions, e.g., "don't". The last two sentences of your abstract in particular are ambiguous.
3. There is no description on the basic contribution of the paper. This should be a few sentences on the topic of the paper. Beginning with this helps the journal editor and lets the author know that you've understood the paper.
4. The Methods section does not clearly explain the data used.
5. It does not discuss results in scholarly manner.
6. Some discussions of the findings of the paper are not yet related to the recent findings
7. Some references are not the recent ones.

SUGGESTIONS FOR FURTHER IMPROVEMENT

1. Rewrite the first sentence in the abstract.
2. Rewrite the ambiguous sentences in your abstract, make it precise.
3. Describe the basic contribution of the paper.
4. Explain and elaborate the data analysis.
5. Discuss results in scholarly manner. Compare and contrast results with existing studies.
6. Relate the discussions of the findings of the paper to the recent findings
7. Update your references.
