General Comments	<ul style="list-style-type: none"> • This manuscript does not follow the author's guidelines; The formats of the writings need to be adjusted. • The abstract does not include an introduction to the investigated topic, an explanation of why the topic is important, a statement about the gap in the research. • The abstract exceeds the 250- word author guideline. • The conclusion must answer the penal policy issues in question • It does not give necessary details on the instruments used. • It does not include ethical practices. • The actual data collection procedures are not discussed. • It does not discuss results in scholarly manner. • It has numerous grammatical errors from the abstract to the sections. • It has typographical errors and errors in mechanics.

The word limit for an abstract should be less than 250 words • Relate the conclusion of the findings to the penal policy issues. • Elaborate and explain the instrumentation used in the research. • Do not describe the nature of the instruments under results. • Categorize observations in creative way. Present them as themes. Do not be repetitive in the presentation of results. • Substantiate results with details like quoted statements and pseudonyms of respondents being described.
