#### Decision: Major revisions required

The article titled "Family aw Reforms from the Criminal aw Perspective in Indonesia "is well written with a substantial area to be addressed. However, there are several areas where the paper could be improved to enhance its clarity and effectiveness.

- Firstly, the paper lacks a clear and concise statement of the research question or hypothesis. While it is mentioned that the study examines family law reforms from the criminal law perspective in Indonesia, the specific research question or objective is not explicitly stated. A clear research question would help readers understand the focus and purpose of the study from the outset.
- Additionally, the paper would benefit from a more detailed description of the methodology employed in the study. While it is mentioned that a judicial legal methodology and secondary qualitative data were used, there is no explanation of the specific sources of data or the analysis process. Providing more information on the methodology would enhance the transparency and reproducibility of the study.
- 3. Furthermore, the paper could provide a brief summary of the main findings or conclusions of the research. It mentions that family law matters in Indonesia are handled by religious and district courts, and certain aspects of the law, such as the minimum age for marriage and protection against domestic violence, are not effectively implemented. However, a more concise and direct statement of the key findings would give readers a clearer understanding of the study's contributions.
- 4. The paper could also benefit from a clearer explanation of the practical implications of the research . While it is mentioned that the study has theoretical and practical implications , no specific examples or recommendations are provided. Including a brief

summary of the practical implications would help readers understand the real -world relevance of the study's findings.

5. Lastly, the paper could be improved by revising the writing style for better clarity and conciseness. Some sentences are overly long and complex, making it challenging for readers to follow the main points. Simplifying the language and sentence structure would enhance the readability of the paper.

- 3. The paper could benefit from a clearer organization and structure. The subheadings and sections could be more distinct and well-defined. This would help readers navigate the content more easily and understand the main themes and arguments presented.
- 4. Lastly, the paper could provide more context and explanation for the significance of the discussed family law reforms . It would be helpful to discuss the societal and legal factors that led to these reforms and their potential impact on individuals and society as a whole.
